OVERVIEW

Clinton School District has prepared this document for the health, wellness, and safety of our students and staff participating in Summer School 2020. As experts continue to learn more about COVID-19, this document will likely change and/or be amended to. The updates/decisions made by Clinton School District will be in conjunction with local and state health officials. **Clinton School District will make every effort to maintain social distancing throughout the entirety of summer school.**

ONLINE LEARNING OPTION

Clinton High School will be offering virtual instruction for Personal Finance and Health. Clinton Middle School will be offering virtual instruction for remediation and enrichment.

TRANSPORTATION

Clinton School District will provide transportation for incoming Kindergarteners thru 5th grade. Bus routes will be posted via our social media and website.

- The number of students will be reduced on each bus. Students will be asked to sit 1 to a seat except for members of the same household who will be asked to sit together.
- Buses will be sanitized between each route.

ARRIVAL

- Parent drop off will be the car lane only to reduce the number of people entering the building. CECC-Parent drop off at front door Henry-Car rider line off of Bodine(line up going east) CIS-Front drive
 - Middle School-Front circle drive
- Parents should remain in their car during drop-off to promote social distancing. Parents can not come into the building for drop-off.
- Please be mindful of students unloading during this time; do not pull your vehicle into motion until all students/staff are clear.
- Students will use hand sanitizer or hand washing upon arrival into classrooms.
- Common areas will be restricted where feasible.

DISMISSAL

- Use of the car line for student pick-up only.
- Parents should <u>remain in their car</u> during pick-up to promote social distancing. Parents can not come into the building for pick-up.
- Be mindful of students loading vehicles around you; do not pull your vehicle into motion until all students/staff are clear.
- CIS car riders with siblings at Henry Elementary will move to Henry for pick-up.

BREAKFAST and LUNCH

- Breakfast and lunch are provided at no charge during summer school.
- Breakfast and lunch will be served in the classrooms with disposable materials.
- All students K-12 will eat breakfast and lunch in their classrooms.
- Students bringing their own lunch need to make sure it is secured in a lunch bag and not handled by other students.
- STUDENTS WILL NEED TO BRING REFILLABLE WATER BOTTLES. WATER FOUNTAINS WILL ONLY BE AVAILABLE FOR REFILLING WATER BOTTLES.

CLASSROOMS

- Upon arrival, students will report straight to their classroom and staff will monitor to ensure no congregating occurs.
- Social distancing strategies will be implemented in each classroom.
- Students will be taught appropriate hygiene/COVID practices and encouraged to maintain distance from each other in school.
- Breaks will be scheduled for frequent restroom and handwashing needs.
- Encourage school buildings to create their own hand signals to replace shaking hands, hugging or giving high-fives.
- Class sizes will limited to 12-14 students.
- Appropriate measures will be taken for cleaning rooms and materials every night and periodically during the day.
- Golden Valley Memorial Hospital has provided free COVID-19 screening to all employees.

PASSING PERIODS

- Passing periods will be limited.
- Movement throughout buildings will be reduced.

VISITORS/VOLUNTEERS

- Parents must call ahead if they have a need to visit the school, outside of an emergency situation.
- No lunch guests or volunteers will be permitted.
- Visitors will not be allowed in the building.

PLAYGROUNDS

- Students will participate in daily outdoor recess, weather permitting.
- Classroom recess equipment used will be disinfected daily.
- Handwashing/sanitizer upon re-entry of buildings.
- Playground equipment will be cleaned between each session.

CLEANING/HYGIENE

- Cleaning with COVID and EPA-approved products for frequently touched hard, non-porous surfaces (counters, tabletops, stair rails, doorknobs, bathroom fixtures, toilets, drinking fountains).
- Hand sanitizer dispensers will be installed throughout the building.
- Students and families will be provided with best practices for hygiene during the school day and upon arriving at home.
- Water fountains will be turned off except for area to refill water bottles.

HEALTH SERVICES

- Parents will check their child's temperature AND screen child for symptoms every morning before school.
- Students will be asked to wash hands while visiting the nurse.
- Students will be sent home for any symptoms of cough/cold/fever >100. The student must be fever-free for 72 hours and symptoms must be improved before returning to school.
- Nursing staff will wash hands and clean health room surfaces (cot, counters, chair, etc.) in between each student seen (only students who require daily medications or have scrapes and bumps will be seen in the nurse's office).
- Students who are ill will be moved to a separate room and will be kept there until parents pick them up (this
 room will be cleaned after each student has been seen). They will be given a mask to wear until being
 picked up. Pick-up **MUST OCCUR** within 30 minutes of call to parent. Please have someone available to
 pick up your child in case of these occurrences.
- School nurses will provide additional COVID safety materials to faculty and staff. These hardcopy materials will be disseminated within the first two days of school.
- If you have medication for your child, please schedule a time with school nurse to drop it off.

PPE

- Use of personal masks will be allowed for students. If desired, students may bring their own masks to wear on buses or at school.
- Parents who send their child with a mask should teach them appropriate usage.
- If a mask or other PPE is disruptive to the educational environment the administrator may call the parent/guardian.
- Use of personal masks will be optional for staff but may be required in special situations.

CSD ACTION PLAN IF CONFIRMED COVID-19 CASE

- Contact Health Department and follow recommended procedures. This could include dismissing all school for up to 2-5 days. Parents/guardians should make sure there is someone available to provide childcare if this occurs.
- Other steps which will be taken

Identify student exposure in relation to direct contact with others and facility exposure Address the infected space using proven practices Perform target cleaning and disinfection of frequently touched hard, non-porous surfaces (counters, tabletops, stair rails, doorknobs, bathroom fixtures, toilets, drinking fountains) Inspect areas to determine readiness for re-entry

Consult with Health Department prior to re-entry
